Dear Sacandaga Group Member,

We have completed the second year of our existing five year contract with Ferrellgas. We doubled our membership again this year and now have over 300 members and used approximately 200,000 gallons this past winter (even though it was unseasonably warm)! We hit a high price of \$2.24 last September and dropped to a low at \$1.84 in February, which was a minimum of \$1.00 under many of the competitors' contract prices. We averaged \$2.03 between October 1, 2011 and March 1, 2012. Our average member saved over \$800 this past winter, most of which were quoted locked in prices of \$3-\$3.25 before joining our Group.
